ANNUAL REPORT 1985-86

Ĭ

GENERAL

The ICHR was set up by the Government of India in 1972 in recognition of the necessity for providing proper directions to historical research and for fostering objective and scientific writing of history. It is an autonomous body established by the Government of India in 1972. The Council is composed of 27 members: a Chairman, 18 historians and 8 ex-officio members. The composition of the Council as on 31st March 1986 is given in Appendix-I. The strength of the staff of the Council is given in Appendix-II.

During the year, as in preceding years, the Council pursued its aims and objects largely through its grants-in-aid schemes. Under this head, it sanctioned a number of research projects, awarded fellowships and study-cum-travel grants and granted assistance towards publications of research monographs; publication of source material and publication subsidies to journals and proceedings of various professional organisations of historians. Emphasis continued to be placed on the hitherto less explored areas of history which include various phases of our freedom struggle, study of South India history and history of science and technology, etc. Besides, the Council has executed the work of the special projects such as 'Towards Freedom' (1937-47) entrusted to the ICHR by the Government of India. Review of progress of historical research, holding of seminars on subjects relating to the different aspects of history, international collaboration, publications, documentation and the publication of Journal (ICHR) constitute some of the major areas of activity of the Council during the period under report.

II BUDGET

. E

During the period under report, the Council received a total grant of Rs. 1,04,08,145/- from the Ministry of Human Resource Development consisting of Rs. 69,08,145/- for non-plan and Rs. 35,00,000/- for plan and Rs. 12,85,000/- for special project (Towards Freedom). As on 1.4.1985, the Council had also Rs. 2,021/- as cash in hand and Rs. 2,85,439/- in the bank, the total opening balance being Rs. 2,87,460. The Council ob ained Rs. 64,212 from the sale of books and royalty (Plan) and Misc. receipts of Rs. 21,851/- inclusive of non-plan and Towards Freedom project. The Council's budget for the year and the Annual Audit Report are given in Appendix III & IV.

III NATIONAL FELLOWSHIPS

In pursuance of the decision of the Council, the modalities for the award of National Fellowships were worked out and the committee constituted by the Chairman awarded six National Fellowships to the following scholars:

Scholars at Sr. No. 1-3 have availed of the National Fellowships and are pursuing the research topics of their own choice. Professor G.S. Talib died and the remaining two have not availed of the fellowships. Under the scheme of National Fellowship which is awarded to eminent historians who wish to work on projects of special historical importance the scholars are provided with fellowship @Rs. 3,000/- p.m. with a contingent grant of Rs. 10,000/- p.a. and secretarial assistance of Rs. 1000/- p.m. for three years.

IV
PROMOTIONAL ACTIVITIES

Promoting historical research is the most important responsibility of the Council. This is being carried out, among other things, through the grants-in-aid schemes of the Council which include (i) sanction of research projects; (ii) award of fellowships; (iii) grant of financial assistance towards stay/travel/contingent expenditure to students doing Ph.D./M.Phil; (iv) grant of subsidy for publishing research monographs; source material; journals etc.; and (v) financial aid to professional organisations of historians. The following table shows schemewise break-up of sanctioned grants during successive years since the inception of the Council.

From the above it may be seen that the number of projects under the Council's grants-in-aid programme has progressively increased. While sanctioning the grant the Council has kept in view its major policy of covering history in its wider sense including the history of art, literature, philosophy, archaeology, military history, epigraphy, economic, social and political development. (For details see Appendices X to XII).

Publication subsidy was approved for 55 books, and 43 professional organisations of historians were given financial assistance for holding seminars, symposia and conferences etc. (The details are given in appendices IV to VI).

Keeping in view the increased cost of living the Council has revised the rates of fellowships as below:

- (i) Doctoral fellowship (Rs. 800/- p.m.) and contingent grant tenable for 2 years initially;
- (ii) Post-doctoral fellowship (Rs. 1000/- p.m.) and contingent grant tenable for 2 years initially;
- (iii) Pay-protection fellowship and contingent grant;
- (iv) Fellowship:
 - University readers/independent research scholars of equivalent experience and status are granted Rs. 1200/- to Rs. 1500/- p.m. for 2 years and contingent grant for 2 years initially;
- (v) Retired University Professor/Independent Senior scholars with equivalent experience and status are granted Rs. 1500/- to Rs. 2000/- p.m. depending on the merit of each case;
- (vi) National Fellowship at the rate of Rs. 3000/- p.m. alongwith a contingent grant of Rs. 10,000/- p.a. and secretarial assistance of Rs. 1000/- p.m. for a period of 3 years granted to eminent historians who wish to work on projects of special historical importance.

It would be seen that out of proposals sanctioned during the year 166 are granted for study/travel/contingent grants sanctioned to the scholars living in different parts of the country, in order to enable them to visit various archival centres in connection with collection of material pertaining to their research pursuits. This scheme of the Council has obviously been found quite attractive and a popular one.

V

COMPILATION OF SOURCES

As in previous years, the Council has been making efforts towards compiling and editing a number of volumes covering all periods of Indian history. A programme to bring out a series of source volumes of all periods of Indian history (ancient, medieval and modern) has been taken up by the Council.

SURVEY PROGRAMME

One of the major aims of the Council is to indicate periodically areas and topics on which historical research needs to be promoted. In fulfilment of this aim the Council undertook the survey programme to see in what direction historical knowledge has been changing in style, content and perspective.

Out of 27 surveys undertaken by the Council nine reports have been completed. Three of these have been published.

- I. Professor Q. Ahmad Mughal Administration
- 2. Professor M. Jha Gandhism and Gandhian Thought
- 3. Professor J.N. Sarkar History of Warfare upto 1914

A circular letter was sent to the various universities requesting them to supply a list of the scholars who are enrolled with them for M. Phil/Ph.D. The information thus collected will be brought out under the title "Yearly Review of Historical Studies in India." This will enable scholars to know the various topics on which the research is going on so as to avoid unnecessary duplication.

VII

OTHER PROGRAMMES AND ACTIVITIES

The Council has also undertaken the responsibility of excecuting some special projects assigned to it by the Government of India. The progress made in the year 1985-86 on these projects is given below.

Towards Freedom Project: (a series of ten vols. 1937-47). Substantial progress on this project has been made in collecting material from scattered sources. This has been typed and xeroxed. Volume I entitled Experiment with Provincial Autonomy (I January-31 December 1937) containing 618 documents and comprising 1358 pages was sent to the press and published during the year. The work on the next volume covering the period 1938 was taken up and selection of material from various records and sources has continued.

Praja Mandal Project

The author has completed the writing of the first part of the projected volume. This is being scrutinised. The author has been requested to complete the remaining portion as early as possible.

VIII

INTERNATIONAL COLLABORATION: PROMOTION OF CONTACTS BETWEEN INDIAN AND FOREIGN HISTORIANS: CULTURAL EXCHANGE PROGRAMME

The ICHR extends financial assistance to scholars proceeding abroad in connection with historical research and to arrange exchange of books/abstracts/journals/microfilms and archival sources, etc. not easily available in the concerned countries, translation of rare historical works and historical material, holding of joint seminars/symposia in the field of historical and other allied subjects having historical content and bias, organising lectures and supporting financially research projects of common interest on subjects in all aspects of Indian history as well as the history of foreign countries with which agreements have been made under Cultural Exchange Programme.

A major activity in the field of international collaboration in which I.C.H.R. participated during the year under report was the holding of an international seminar under the Indo-Soviet Cultural Exchange Programme. The theme of the seminar was "the Transition from Ancient to Medieval Periods: Problems of Economic and Social Organisation of Society in India and the U.S.S.R." It was held in New Delhi from 11 to 13 April, 1985. It was inaugurated by Dr. Lokesh Chandra, the then Chairman, ICHR. It was attended by distinguished historians from India and the U.S.S.R. (the list of the participants etc. is given in Appendix VII).

During the period under report, the Council also participated in the seminar held in Berlin in July, 1985 under the Indo-GDR Cultural Exchange Programme. The theme of the seminar was "Agrarian Questions and Peasant Movement in German and Indian History from 16th to 20th Centuries". The details of the participants are given in Appendix VIII.

In November, 1985, the Council sent a delegation of historians to take part in the Indo-Bulgarian seminar at Sofia.

The theme of the seminar was "Socio-Economic and Political Aspects of the Struggle for National Liberation during the 19th and 20th Centuries". (The details are given in Appendix-IX) The papers of this seminar are being edited and will be published in due course. Books, journals and other publications were sent to Hungary, Turkey, Mexico, Bulgaria, Soviet Union and other countries under the Cultural Exchange Programme.

Financial assistance and other facilities were provided to two German scholars to work on their research projects for a period of three months under the Indo-GDR Cultural Exchange Programme.

IX

FOREIGN TRAVEL GRANTS

Eighteen scholars were given grants to participate in International Congresses/Seminars and for collection of source material from abroad. Five scholars were given financial assistance to attend the VII Conference of International Association of Buddhist Studies held at Bologna, Italy in July 1985. Nine scholars were extended financial assistance for collection of source material abroad, on their individual research work.

X PUBLICATIONS

During the period under report the Council published the journals, books and processed various manuscripts for publication.
