## ANNUAL REPORT : 1986-87

### I GENERAL

Set up by the Government of India, in 1972, as an autonomous institution funded through the Ministry of Human Resource Development, the ICHR has been fulfilling its objective through organising and supporting various academic and research projects. Oriented towards promoting a scientific and secular approach to history the Council awards fellowships, study-cum-travel grants and publication subsidies to those engaged in historical works. The Council also disseminates results of historical research through an ambitious publication programme. This comprises the compilation and publication of a series of source books pertaining to all periods of Indian history and a biannual journal—*The Indian Historical Review*. It organises seminars and academic conferences and funds travel within and outside the country for academic purposes. The Council also maintains a large and continuously-expanding library for use of historians and researchers.

The Council is headed by a Chairman. It has twenty-seven other members of whom 18 are historians and 7 ex-officio members, including the Education Secretary, Secretary, Culture, Financial Adviser, HRD Government of India, heads of the National Archives of India, the Archaeological Survey of India, the U.G.C., etc. The composition of the Council as on 31st March, 1987 is given in Appendix-I. The strength of the Council as on 31st March, 1987 is given in Appendix-II.

During the period under review the Council continued to place emphasis on the less explored areas of research which include prehistory proto-history, social and economic history, history of art, military history and historical geography. The special project assigned by the Government of India to the Council, the *Towards Freedom Project*, also

registered progress, Vol. I is published and Vol. II is under publication. Manuscripts were received under other special projects of the Council like the *Praja Mandal Movement*, *State Legislature Project*, *Translation Project* and *Sources on Indian Civilization and Culture* for publication. To combat divisive forces in the country, such as communalism and regionalism, the Council plans to bring out a series of books in all Indian languages depicting cultural and national integration. The sale of back numbers of the *Indian Historical Review* has greatly increased this year as a result of a special promotional campaign.

## II

### BUDGET

As on 1.4.1986 the Council received a total grant of Rs 1,08,86,000 from the Ministry of HRD consisting of Rs. 35,00,000 for the plan and Rs 7,00,000 for the special project, *Towards Freedom 1937-1947*. The Council had also Rs. 18,707/- as cash in hand and Rs 14,85,535/- in the bank, the total opening balance being Rs. 15,04,242/- and from the sale of books and journals and royalty (plan) and miscellaneous of Rs. 2,17,261 inclusive of non-plan and *Towards Freedom Project*. Besides, the Council had received Rs. 78,000 from UNESCO for its Seminar. The Council budget for the year and the Annual Report are given in Appendices III and IV.

## III

### FUNDING HISTORICAL RESEARCH

The most important responsibility of the Council is to provide funds for research and publication, with a rigorous assessment of their quality and a close monitoring of results. The grants-in-aid schemes of the Council include (i) sanction of research projects; (ii) award of fellowships; (iii) award of study-cum-travel grants to the research workers pursuing M.Phil and Ph.D. degrees; (iv) grants of subsidies for publishing research monographs, source material, journals, etc. and (v) financial assistance to academic organisations of historians. The following table shows the scheme-wise break up of sanctioned grants during successive years, since the inception of the Council.

It may be seen from the above table that the number of projects, fellowships and study-grants has generally been on the increase, though during the last two years, owing to a more rigorous screening, there has been a slight decline. While considering the applications for various grants-in-aid, care has been taken to ensure that all aspects of Indian history are adequately covered. Efforts are also made to see that the Council's grants are evenly distributed over the various parts of the country. (Details of such grants may be seen in Appendices V, VI and VII.

Results of historical research should be published at a reasonable price and therefore, publication subsidies have been approved for 62 books during the year 1986-87. Since the Council aims at providing a forum for exchange of ideas pertaining to historical research, it has extended financial assistance to 40 professional organisations for holding seminars, symposia and conferences. (The details are given in Appendices VIII and X).

#### IV NATIONAL FELLOWSHIP

During the period under report, four scholars were offered national fellowships. Professor G.S. Talib could not avail the fellowship due to his demise. Professor S. Gopal declined it. Dr. P.N. Chopra proposes to join the fellowship in November 1987. Professor A. R. Kulkarni joined the national fellowship at the end of the year under review.

Keeping in view the increased cost of living and contingent items the Council has revised the rates of fellowships and contingencies w.e.f 1.1.1987 as noted below :—

##### **Fellowships other than National Fellowship :**

(i) Junior Fellowship : Rs. 800/- p.m. along with a contingent grant of Rs. 3000/- p.a. for 2½ years extendable by one year

(ii) Post-Doctoral Fellowship: 1200/- p.m. along with a contingent grant of Rs. 3000/- p.a. to Rs. 5000/- p.a. according to the merit of each case.

(iii) *Pay-Protection Fellowship* : The number of pay-protection fellowships was limited to ten in one financial year. Contingencies in respect of pay-protection fellowships have been fixed at Rs. 5000/- p.a.

(iv) *Senior Fellowship* : Depending on the merit of each case there are three categories of Senior Fellowships which are as follows :

(a) Rs. 1500/- p.m. alongwith a contingent grant of Rs. 3000/- p.a.

(b) Rs. 2000/- p.m. alongwith a contingent grant of Rs. 5000/- p.a.

(c) Rs. 2500/- p.m. alongwith a contingent grant of Rs. 8000/-p.a.

The award of Senior Fellowships in the three categories would generally correspond to scholars who may be assigned the academic status equivalent to respectively (A) Lecturers (B) Readers and (C) Professors.

#### V PUBLICATIONS (Compilations of Sources)

One of the objectives of the Council has been to give strong source orientation to the teaching and research in history. The Council also

## VI SPECIAL PROJECTS

*Towards Freedom Project 1937-47.* During the period under report relevant material for volume II covering the period 1938 was collected from various institutions. Material already collected has been typed, xeroxed and prepared in the proper form of documents to be included in the forthcoming volume. Material from India Office Library, London, has also been collected for the proposed volume. The manuscript will be ready for the press by June 1987. An Advisory Committee of the "Towards Freedom" project met in February 1987 and laid down certain guidelines for the expeditious completion of the work.

*Praja Mandal Movement :* The manuscript has been received from the author and is being examined.



*INTERNATIONAL COLLABORATION* : Promotion of contacts between India and foreign historians : Cultural Exchange Programme.

As reported in the last *Annual Report* the Council organises seminars on the themes of historical significance under the Cultural Exchange Programme. It also subsidises travel by Indian historians and hosts guest historians from other countries. It arranges exchange of books, abstracts, journals, microfilms and archival source materials not easily available in India.

During the period under report the Council sent lists of its publications to Afghanistan, Australia, Bahrain, France, Greece, Iraq, Mauritius, Mexico, Norway, Poland, Tunisia, Turkey and Uganda. On request from Afghanistan, Cyprus, Mexico and Turkey, the Council's publications were despatched to the Indian Missions for onward transmission to our counterparts in these countries. The Council has also received some books from Cyprus.

Under the Indo-USSR Cultural Exchange Programme, a symposium on *Village Community in India and the USSR during the 18th—early 20th centuries* was held in Moscow from 11 May to 23 May 1986. Five scholars from India, Dr. K. Seshadri, JNU; Dr. Padmasha, Department of History, Bihar University, Muzaffarpur; Dr. T.R. Sareen, Director, ICHR; Dr. R Tirumalai, Madras; and Professor N. S. Bose, Santiniketan, presented papers at the seminar. Seven scholars from the Academy of Sciences, USSR, participated in it. The Council was represented by the Director at the 10th International Association of Historians of Asia which was held at Singapore from 25 October 1986. Director read the paper on *Japan and Indian National Movement 1905-1945*. He was elected as one of Vice-Presidents of the next conference to be held in Sri Lanka in 1988.

## VIII ICHR SEMINARS

Since the Council also aims at providing forum for exchange of ideas among the historians, three seminars one each at Santiniketan, Lucknow and Calicut, took place during the period under report. In

collaboration with the Department of History, Visva Bharati University, Santiniketan a seminar on *Tagore's Concept of History and Human Civilization* was organised from 27th February 1987 to 1st March 1987 as part of celebrations of the 125th Birth Anniversary of Rabindranath Tagore. It was addressed by eminent scholars like Professor N. S. Bose, Professor Ashin Das Gupta and Professor J. C. Jha. Thirty-five participants including five key speakers from Bengal and Assam participated in it.

Another seminar on *U. P.'s Role in the Freedom Struggle* was organised at Lucknow with the collaboration of the Department of Medieval and Modern History from 16th January 1987 to 18th January 1987. Prominent participants who presented their papers to the seminar included Dr. Kapil Kumar (Delhi), Dr. Sushil Srivastava (Allahabad), Dr. A. K. Sharma (Lucknow), Dr. Vandita Verma (Allahabad) and Shri T. N. Mishra (Allahabad). The seminar was also addressed by Professor S. N. Qanungo and Professor S. P. Nagendra. The proceedings of the seminar are being edited for publication. Nearly 50 young research scholars from all over U.P. actively participated in the discussions.

The last ICHR seminar in the financial year, 1986-87, was organised at Calicut by Professor M.G.S. Narayanan, Head of the Department of History, Calicut University, Calicut, Kerala from 12th February to 14th February 1987. It was devoted to *State formation in South India*. It was attended by 60 participants from Kerala, Tamil Nadu, Andhra Pradesh and Karnataka. Nearly 20 research papers were presented. Prominent among the participants were Professor Y. Subbarayalu, Professor M. P. Sridharan, Dr. Aloka Parashar, Dr. K. Gopalankutty, Dr. M. Gangadharan, Professor R. Champaklakshmi and Dr. Rajan Gurukkal.

**UNESCO's Regional Training Seminar on the use of Quantitative Techniques and Serial Methods in the Science of History.**

In collaboration with the Regional Adviser for Social and Human Science in Asia and the Pacific, Bangkok, a regional workshop on the subject was organised by the Council from 28th January to 7th February 1987 at New Delhi. In association with ICSSR and National Commission for cooperation with UNESCO, the seminar aimed at exposing the scholars in history to new advances in methodology with particular

emphasis on quantification. Included in the theme of the seminar were (i) the precise nature of quantification techniques being applied in history; (ii) the extent to which quantification techniques have been applied in the study of history in various Asian countries and (iii) the need for further application of quantification to history of Asian countries.

The seminar was attended by ten participants from nine countries, China, Thailand, Sri Lanka, Malaysia, Pakistan, Philippines, Nepal, Indonesia and India. Two resource persons were invited from India and Australia. Inaugurated by Professor Iqbal Narain, Member Secretary, ICSSR, the opening session was addressed by Professor Amalendu Guha, Course Director, and Professor Irfan Habib, Chairman, ICHR who delivered the key note address on *Quantification in Indian History*. Miss Koto Kanno, the UNESCO representative, also spoke. During the 18 sessions the seminar was addressed by 25 guest speakers which included Professor Dharma Kumar, Professor R. S. Sharma, Professor Om Prakash, Dr. John Mcquire, Professor S. Bhattacharya, Dr. S. Moosvi, Dr. Durga Prasad Bhattacharya, Professor Y. Subbarayalu and Professor R. K. Habsur. The themes discussed in the seminar included *Methods of Quantification in History*, *South Asian Historical statistics in the late and early 19th century*, *Problematic nature of Quantitative history*, *The South Asian case*, *Quantative approach to the study of social and economic history of early India* and *Methodologies applied in the historiography of Medieval South India*.

Ten country reports on the use of Quantitative methods applied in the countries concerned were presented at the seminar. The Council made available to the participants sets of relevant reading material besides a select bibliography on the use of Quantitative Methods in history.

## IX

### THE INDIAN HISTORICAL REVIEW

The manuscript of IHR, Vol. X, Nos. 1-2, a double issue, comprising six articles two review articles, fifty-eight reviews of books, two short notices and two tributes has been sent to the press and is due to be

released shortly. The material of Vol. XI, Nos. 1-2, another double issue has been edited and is expected to be sent to press in May 1987.

A meeting of the Editorial Board of the IHR held in October 1987 has decided to raise the honorarium for an article to Rs. 300/- and for a book review to Rs. 150/-. It was decided that a few thematic issues of the IHR should be brought out and that the Council should plan and organize seminars for the specific purpose of feeding these issues. Two themes suggested for the seminars are *Religion and Society in Indian History and State Structure in South the India*.

To mark fortieth year of our Independence, it has been decided to bring out a special issue of IHR (Vol. XII No. 1-2) on the *National Movement*.

## X

### DOCUMENTATION-CUM-LIBRARY CENTRE

During the period under report the expenditure for acquisition of books and journals was greatly increased, the amount spent during 1986-87 amounting to Rs.8,40,848. 2108 new books covering all branches of history have been added. Besides the *Houghton Shah Nama* in 2 vols., *Encyclopaedia of Religions* in 16 vols. *Agni* in 2 vols. *old Census Reports*, *Reprint edition of Indian Culture* in 16 vols, *Science and civilization in China*, 7 vols. in 14 parts and *Encyclopaedia Indica* in 25 vols. have been added. 23 serials of rare Journals in microfiche prepared by Inter-Documentation Company, Switzerland, have been requisitioned. Back volumes of *Past and Present* and *Bulletin of SOAS* are being acquired. The Council has also acquired on exchange basis the back volumes of *Pakistan Historical Society* with that of *Indian Historical Review*. The reading room of the Library has been renovated to accommodate a large member of research scholars.

The Documentation Centre has also brought out accession list as well as the list of important articles bearing on Indian History in various Journals and periodicals published both in India and abroad under the title *Current Awareness Services*.

## XI EQUIPMENT

The ICHR acquired a word-processor with considerable software so as to assist composition of press copies and documentation services. A new photocopier has been installed in view of the increasing demand for photocopying of portions of books and articles by scholars. Electronic typewriters have been provided to all important units to increase efficiency.

## XII PUBLICITY

As recommended by the Review Committee a great deal of the publicity was given to the Grants-in Aid programme of the Council during the period under review. Two brochures were brought out under the title. Information Bulletin Nos. I and II. The Information Bulletin No. I gives in brief the various Grants-in Aid schemes which are being financed by the Council, specially the award of fellowship/research projects, assistance to professional organisations of historians, publication subsidy, study-cum-travel grants, etc. The Information Bulletin No. II gives information about the various publications of the Council which are available at a concessional rate. These bulletins have been sent to all the Universities and research institutions so that more and more scholars from all over the country can utilise the financial assistance granted by the Council.

The Council has also taken steps towards compiling the *Directory of Indian Historians* for which a proforma was sent to almost all Universities and research institutions. The information thus collected will be compiled into a book form for the ready reference of the scholars.

An Advisory Committee of the Council has suggested some guidelines to promote objective and anti-communal projects in history so as to present an integrated view of our culture and society. To popularise the secular concept in Indian history, the Committee made specific recommendations regarding translation of books, publication of documents, reports and text books used at the Universities and Colleges.
