INDIAN COUNCIL OF HISTORICAL RESEARCH

ANNUAL REPORT 1987-88

I GENERAL

The Indian Council of Historical Research was established in 1972 as an autonomous body with a view to providing funds for historical research and to foster objective and scientific study of history. The Council awards fellowships, Study-cum-travel grants and publication subsidies. It also endeavours to make available source material as well as results of historical research through an ambitious publication programme. It also brings out a Journal *The Indian Historical Review* which includes interpretative papers and reviews. It organises Seminars and academic conferences and gives financial assistance for travel within and outside the country for conducting historical research. The Council also maintains a large and continuously expanding library for the use of historians and researchers and also provides documentation services,

The Council has a Chairman and 27 other members of whom 18 are historians and 7 ex-officio members representing the Secretary, Ministry of Human Resource Development; Secretary, Department of Culture; Financial Advisor of Ministry of Human Resource Development, Government of India, the National Archives of India; the Archaeological Survey of India; the U.G.C.; etc. The appointment of the members is made by the Government of India for a period of three years. The composition of the Council as on 31 March 1988 is given in Appendix-I. The strength of the Council as on 31 March 1988 is given in Appendix-II.

During the period under Review the Council continued to place emphasis on the fulfilment of its aims and objectives by focusing attention on the less explored areas of research which include study of socio-economic formations, History of Ideas, History of Peasantry and

Agrarian Relations, Urban studies, Demography and kinship studies, Quantitative History, Freedom Struggle, Regional History and History of Science and Technology. Emphasis was also placed on the editing, calendaring and translation of historical sources in both regional and foreign languages.

The work on the special project "Towards Freedom" assigned by the Government of India was re-organised. The compiling and editing of the remaining volumes has been assigned to different Volume Editors and it is expected to finish the work by 31 March 1992. Work is continuing on other projects, "Role of the State Legislatures in the Freedom Movement", "Praja Mandal Movement", "Sources of Indian History and Civilization and Culture"

II BUDGET

During 1987-88 the ICHR received a total grant of Rs. 1,32,85,000/- from the Ministry of Human Resource Development. This comprised Rs. 40,00,000/- for Plan, Rs. 75,00,000/- for Non-Plan and Rs. 17,85,000/- for "Towards Freedom". As of 1-4-1988, the Council also had Rs. 6,909/- as cash in hand and Rs. 4,09,558/- in the Bank, the total opening balance being Rs. 4,16,467. The Council realised a sum of Rs. 1,61,898/- from sale of books/journals and royalties. Its Accounts for 1987-88 and the Annual Audit report may be seen at Appendices III & IV respectively.

III FUNDING HISTORICAL RESEARCH

The most important objective of the ICHR is to provide funds to scholars/institutions for research and publications. The Grants-in-aid schemes of the Council includes provision of funds for (i) Research Projects; (ii) Fellowship; (iii) Study-cum-Travel Grants to researchers pursuing M.Phil and Ph.D.; (iv) Publication subsidies, and (v) financial assistance to academic organisations of historians. The detailed information about the grants-in-aid provided to various scholars/organisations since inception of the Council till March 1988 is given below :

The detailed list of Research Projects, fellowships and study grants sanctioned during 1987-88 may be seen in Appendices V, VI & VII. It will be seen that the number of projects/fellowships/study grants showed a large increase during the year 1 87-88. Proposals for grants-in-aid are carefully examined by experts and then placed before the Research Projects Committee/Study Grants Committee. Attention is paid to ensure that the grants are distributed evenly in different parts of the country.

During the year under report, the Council has provided publication subsidy to 89 books. While acting as an agent for exchange of ideas the Council provided financial assistance to 56 institutions for holding seminars, symposia and conferences. Detailed list of publication subsidies and financial assistance sanctioned to Professional Organisations of Historians is given in Appendices VIII & IX respectively. A detailed list of scholars who were provided travel subsidies to visit abroad to attend seminars/conferences is given at Appendix X.

IV

NATIONAL FELLOWSHIPS

National Fellowships are awarded to eminent historians who wish to work on projects of special historical importance (fellowship Rs. 3,000/- p.m.; contingency Rs. 10,000/- per annum and secretarial charges Rs. 1,000/- per month for a period of three years). At any one time there cannot be more than six National Fellows. Those who carried on research under this scheme during this period were :

VI SPECIAL PROJECTS

The work pertaining to the "Towards Freedom" project has been reorganised in accordance with the decisions taken by the Advisory Committee at its meeting on 20 August 1987. In order to expedite the completion of the work pertaining to the remaining volumes, the Committee decided that the work may be assigned to different Volume Editors with adequate staff. The text of Volume II which had been completed by the former Chief Editor is being checked. Besides assigning the work to different Volume Editors the Committee further decided that each Volume Editor be paid an honorarium of Rs. 25,000/- for editing of the volume and that he may complete the work within a period of two years. Besides the old guidelines for the compilation of these Volumes fresh guidelines have been prepared to facilitate uniformity of coverage and selection among the volumes. It has also been proposed to establish close liaison between the ICHR and the National Archives of India for expediting the collection of material and compilation of these volumes.

Praja Mandal Movement

As already reported in the previous year the manuscript has been received and is under scrutiny for judging whether it is suitable for publication.

Sources of the National Movement

The volume containing selected documents for 1920-1922 was received from the editor Professor S. R. Singh and is being processed for publication.

VII INTERNATIONAL COLLABORATION

The promotion of contacts between India and the historians of the other countries was carried on under the following heads during the period under review :

1. Holding of joint Seminars and exchange of visits by historians and exchange of books, abstracts, journals under the Cultural Exchange Programme between India and other Foreign countries.
2. financial assistance to scholars to attend international seminars symposia, conferences, etc.
3. assistance to Indian scholars to visit archival repositories and archaeological sites abroad for collection of material.

A major activity in the field of international collaboration in which ICHR participated during the year under report was the holding of an Indo-Soviet Seminar on *Colonialism and Capitalism* by the Council from 11-13 January 1988. This was organised under the Cultural Exchange between Government of India and the Soviet Union. It was inaugurated on 11 January 1988 by Professor Iqbal Narain, Member Secretary, ICSSR. The inaugural session was addressed by Professor G.G. Kotovsky and Professor Irfan Habib, who delivered a key-note address on "Relationship of Capitalism and Colonial accumulation—The Indian Case". The Soviet delegation presented papers on different aspects of Colonialism and Capitalism. Dr. G.G. Kotovsky, Professor L. B. Alayev, Dr. E. N. Komarov, Professor N. A. Ivanov, Professor O. V. Maliarov, Professor E. O. Berzin, Dr. I. O. Levtonova and Dr. A. G. Volodin participated on the Soviet side. The Indian scholars included Professors A. K. Bagchi, Amalendu Guha, Ravinder Kumar, Bipan Chandra, K. Rajayyan, Divijendra Tripathi, P. S. Gupta, S. Bhattacharya, M. J. Mehta, Tan Chung, Diptendra Mohan Banerjee, Utsa Patnaik and Irfan Habib. In all 20 research papers devoted to the main theme of the seminar were presented.

Exchange of Scholars

Under the Cultural Exchange programme three Indian scholars were nominated to visit G. D. R., Netherlands and Italy for the collection of source material pertaining to their topic of research or to participate in Seminar. Two scholars from Afghanistan, one each from German Democratic Republic and Netherlands came to India for collection of material in different repositories in India in connection with their research.

During the same period under the Cultural Exchange Programme publications of the Council were exchanged with institutions in the following countries :— 1. Afghanistan, 2. Australia, 3. Bangladesh, 4. Cyprus, 5. Finland, 6. Jordan, 7. Turkey, 8. Yugoslavia, 9. Czechoslovakia.

Publications from some of these countries were also received by the Council. In order to promote better understanding between the Indian historians and historians from foreign countries the Council invited three historians Professor Peter Hardy from U.K., Dr. Dolores Domin from GDR and Professor John Savile from U. K. They delivered lectures at different Universities and also had the opportunity of interacting with the Indian historians. Two other scholars Dr. Othman Yatin from Malaysia and Dr. N.K.U. Moula from Bangladesh were given financial assistance to visit India in connection with their research work for a period of two weeks.

Foreign travel grants were given to 11 scholars to go abroad for collection of material in connection with their research work, 24 scholars were sent to participate in international Conferences, viz. VII World Sanskrit Conference at Leiden (Netherlands), Inter-national Congress of Historical Demography, Paris, XVI International Conference of Onomastic Sciences, Quebec, etc.

VIII

SEMINARS / WORKSHOPS, CONFERENCES

The ICHR gave financial assistance to 59 professional organisations of historians for holding conferences, seminars, etc. both at the regional and national levels. These include the Indian History Congress for

holding its Golden Jubilee Session at Goa, Orissa History Congress, South Indian History Congress, Punjab History Conference, Indian History and Culture Society, North-East Indian History Congress, Indian Archaeological Society, Numismatic Society of India, etc.

Financial assistance for the Publication of the historical journals and the proceedings of the various conferences was given to *Man and Environment*, *Puratattva Journal of Oriental Research*, *Quarterly Review of Historical Studies*, Proceedings of the Indian Archaeological Society, Numismatic Society of India, Andhra Pradesh History Congress, Indian History Congress, U.P. History Congress, etc.

As a part of the programme to celebrate the 40th Anniversary of Indian Independence and centenary of Pandit Jawaharlal Nehru it was decided by the Council to hold Workshops on the National Movement at different Universities in India.

IX

THE INDIAN HISTORICAL REVIEW

Two double issues of the Journal "The Indian Historical Review" were released during the period under report. Volume X Nos. 1 & 2 was released on 3-6-1987 and Volume XI Nos. 1 & 2 was released on 12-2-1988. The Volume X comprised 6 articles, 2 review articles, 58 reviews of books, 2 short notices and 2 tributes. Volume XI comprised 6 articles, 5 review articles, 75 reviews of books and 3 tributes. In addition some reports and the style-guide for The *Indian Historical Review* are also included in Vol. XI.

Work for editing Vol. XII Nos. 1 & 2 which is devoted to the theme of *National Movement* was also initiated and substantial progress achieved in preparing its materials.

X

DOCUMENTATION-CUM-LIBRARY CENTRE

During the period under report the expenditure for acquisition of books, journals and articles was further increased. The ICHR documentation centre acquired 3782 books covering various branches

of Indian History and the history of other countries. Among the important acquisitions may be mentioned (a) Bibliotheca Indica, a reprint of the volumes originally published by Asiatic Society, Calcutta: 80 volumes have been received and the remaining volumes which are under print will be acquired as and when brought out and (b) soft-bound xerox copies of 101 dissertations on Indian subjects approved by foreign Universities.

The major work of documentation has been the compilation of *Papers on Indian History* published. Articles on Indian History in various journals covering the period January to December, 1986. The volume has been published and widely distributed. In addition the centre has also taken in hand the listing of articles covering the period January-December 1987 and a considerable work has been done.

XI

OTHER SIGNIFICANT ACTIVITIES

To celebrate the 40th Anniversary of India's Independence and Nehru's Birth Centenary the Council at its meeting held on 4 August 1987 decided to make its own contribution by preparing and publishing a volume entitled "We have Fought Together for Freedom" initially in English and Hindi and then in other Indian languages.

The volume will consist of a number of chapters each devoted to a particular incident or phase of the Freedom struggle to be contributed by a particular scholar. More than twenty scholars have been asked to contribute. Considerable progress was achieved during the period under report, and it is proposed to bring out the volume by the end of 1988.

During the period under review, the Council also decided to hold a seminar on "New Archaeology and India" in October, 1988. The Seminar will be problem oriented and devoted towards methodology and present state of discipline. It is hoped that it would be beneficial to the practicing archaeologists and historians. About twenty Indian scholars and four Foreign scholars have been invited.
